Course Description

Ayn Rand, who was born in Russia in 1905 and who emigrated to the United States in 1926, is easily the most recognizable philosopher of the twentieth century—that is, if one recognizes her as a philosopher in the first place; for no other intellectual in the twentieth century has aroused so passionate and acrimonious a debate about whether her work is “worthy” of being called “philosophy” (with Jacques Derrida and Martin Heidegger standing as a distant second and third). The lingering controversy surrounding her legacy since her death in 1982 is perhaps befitting someone whose fictional heroes were often as uncompromising and idealistic—and repugnant, depending upon one’s point of view—as their author. In this course, we will critically engage Rand’s major fictional texts, *The Fountainhead* (1943) and *Atlas Shrugged* (1957). We will also, drawing upon the work of political columnist and satirist Mark Steyn, consider whether—or to what extent—Rand’s prophetic vision of the political, cultural, economic, and moral dissolution of the United States in *Atlas Shrugged* is taking place before our very eyes

The major assignments for this course will be daily reading cards, seven reading quizzes (lowest score dropped), an in-class project, and a cumulative take-home final examination.

Attendance Policy

Attendance is mandatory, and active participation is expected. Attendance will be taken in the following way. At the start of each class, you must submit a 4x6 index card that contains the following:

- *Front of card:* name, date, 1-2 sentence summary of a single chapter from the assigned reading
- *Back of card:* a comment or open-ended question that could be used to facilitate class discussion

Excluding the first day of class, we have 8 scheduled meetings that involve newly assigned readings; however, since it is not always possible to attend class, I will expect from you a maximum of 7 cards, which means that you have one excused absence. If you submit 8 reading cards, then you will receive 1% extra credit toward your final course grade. Note: You should always bring a separate copy of your comment or question to class so that you can refer to it during class discussion.

Please note:

- Incomplete cards will receive at most half-credit.
- You must be present in class in order to submit reading card; I will not accept cards that are submitted via email, put in my mailbox, shoved under my office door, etc., even if are turned in early.
- If you are late for class by no more than 20 minutes, please hand your card to me as soon as you enter the classroom. If I have not yet collected the reading cards, you will receive full credit; if I have already collected them, you will receive half-credit.
- Cards submitted later than 20 minutes after class has started will not receive credit; if you are uncertain about how late you are, please ask me after class.
- Cards that explain why you have not written a summary and question will not receive credit!

The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
