Time and Place of Class Meetings: Tues. 5:30, course is listed as meeting in GS109, but we will likely move to ERB 4th floor conference room after the first meeting.

Description of Course Content: This is a graduate course that covers the classification of transposable elements, and the mechanisms and regulation of transposition in a broad range of organisms. In addition to traditional lectures given by the instructor, students will present and discuss papers among the classic and recent literature on the topic.

Student Learning Outcomes: Students will gain a working understanding of the types of transposons, how they replicate, and how they are regulated.

Required Textbooks and Other Course Materials: primary research papers and review articles (TBA).

Descriptions of major assignments and examinations: grades will be based on student presentations, class participation, and a final exam/paper.

Attendance: attendance is mandatory.

Other Requirements:

Grading: grade based on (likely) 2 talks, a literature review, and on class participation. Roughly equally weighted. Subject to change depending on class size and other factors.

Expectations for Out-of-Class Study: Read the assigned papers and explore beyond.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period.
