Course Description

Contents and Objectives:

This course will engage students in individual, student-designed projects, where students will design and implement advanced computer vision methods. Topics of interest include, but are not limited to:

- detecting and recognizing people in a scene.
- detecting and tracking individual body parts such as faces and hands.
- model-based and exemplar-based methods for recognizing gestures and signs.
- object recognition.
- camera calibration.

The main deliverable for each student will be an individual project. The project will be graded based on:

- degree of difficulty
- system performance (accuracy, efficiency, generality)
- ability to visualize and understand the behavior of the overall system as well as individual system components
- quality of the experimental evaluation
- quality of written reports and oral presentations about the project.

Students will specify their project at the beginning of the course and will deliver progress reports on a weekly basis. A second deliverable will be student presentations of their work. To compute the semester grade, a weight of 75% will be assigned on the project, and a weight of 25% will be assigned on the quality of the presentations.

Class lectures will consist of student presentations of their own work, as well as presentations of published papers highly related to students' projects. After the presentations, the students and instructor will discuss and offer suggestions for the next steps in each student's project.

Projects are due December 3. Depending on the type of project, the submission format (e-mail, web page, flash drive) will be arranged between the student and the instructor.

Prerequisites:

Students are assumed to already have adequate computer vision background, by having taken the CSE 6367 course at UTA, or equivalent courses elsewhere. Alternatively, for students who do not have formal background in computer vision, they must meet with the instructor to discuss their background and obtain permission to register.

Course Materials:

Course materials will be available electronically on the course web page. Changes and corrections, if any, will also be announced by e-mail to the course mailing list.

Emergency Exit Procedures

Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit:

- Safely and calmly exit the classroom using either of the two doors.
- After exiting the door turn left, and walk to the end of the hallway, which is approximately 50 feet away from ERB 129.

When exiting the building during an emergency, one should never take an elevator but should use the stairwells. Faculty members and instructional staff will assist students in selecting the safest route for evacuation and will make arrangements to assist handicapped individuals.
