Course Overview

This course is a continuation of Linguistics 5330 (Formal Syntax). Whereas 5330 dealt mainly with “A-movement” (subject-raising, passive, etc.), this course will focus more on “A-bar movement” (wh-movement). A-bar movement is central to a number of syntactic constructions including, but not limited to constituent questions, relative, and comparative clauses. Our focus will be on constructions of this sort. This course will also be concerned with the broader issues of the architecture of grammar, relating—in particular—to the interface between Syntax and other components of grammar (i.e. Phonology, Semantics).

Course requirements

- Problem sets (roughly 6).
- Progress reports (roughly, every other week) on your original research paper.
- Original research paper.

The problem sets will have the same basic format as those in 5330. Progress reports should be a minimum of 1 paragraph and a maximum of 1 page. The final paper will be due at the end of the semester, but you should start working on it at the beginning of the semester and continue working on it throughout the semester.

Grading

Except for progress reports, which will be graded on pass/fail, problem sets and the research paper will receive a letter grade. In calculating your final grade, each letter grade you earn will be converted to a numerical value between 0 and 4 as follows: A = 4, A- = 3.5, B = 3, B- = 2.5, C = 2, C- = 1.5, D = 1, D- = 0.5 and F = 0. At the end of the semester, grades will be averaged and weighed based on the percentages stipulated below to determine your final grades. Final grades will be assigned as follows: 100-90% = A, 89-79% = B, 78-68 % = C, 67-57% = D, 56-0% = F.

- Problem sets and final paper = 80%
- Progress reports = 10%
- Participation (attendance, etc.) = 10%

Other information

There is no textbook for this course, though there will be occasional readings. The structure of this course will be roughly the same as 5330, where the topics discussed in a given week build on what was covered in previous weeks. Thus, it is important that you attend class and it is equally important that you have a reasonably good grasp of the material that we are covering. Unlike 5330, however, we will not always be concerned with providing a solution to particular problems, as the focus will quite generally be on the broader and open analytical and theoretical issues of syntactic theory.

Outline of topics we are likely to cover, roughly in the order in which they will be covered

2. The theory of *Agree*
3. Wh-movement
4. Relative clauses
5. Other “A-bar” constructions
6. Islands
7. Successive Cyclicity
8. Logical form
9. Ellipsis

Class Policies
