Prerequisites: CE 3341 with a grade of C or better and Civil Engineering-BSCE academic plan.

Required Textbook: *Structural Concrete: Theory and Design,*
Hassoun, M. Nadim, and Akthem Al-Manaseer, 5th edition, John Wiley & Sons, 2012

Course Content: An analysis, design and synthesis course for concrete structures, emphasizing elastic analysis and strength design. Topics include strength and serviceability requirements. Design of one way slabs, rectangular beams, flanged sections and columns, and footings for strength, shear, bond, bearing, and serviceability. Building codes, American Concrete Institute (ACI) specifications, material specifications, test methods, and recommended practice documents.

Techniques, Skills, and Modern Engineering Tools Used in this Course:

Students are encouraged to use the engineering software tool Mathcad on homework.

Homework: A number of relevant homework problems, grouped into one or more problem sets will be assigned on the class website or given in class at the end of lecture.

Assignments will be collected in class at the beginning of a lecture in hard copy. Late Homework will NOT be accepted unless arrangement has been made in advance with the instructor. Homework are suggested to be in a standard format. This includes: (a) statement of the problem (with a sketch); (b) quantities with given values; (c) quantities to be found; and (d) solution of the problem. Draw a box around the answer(s).
