Description of Course Content: The nature and properties of materials used in civil engineering such as structural metals, concrete, timber, and bituminous materials. The engineering properties and behavior of materials are emphasized.

Due to the time restraint, only the following materials will be discussed in this semester: Wood, Aggregates, Cement Concrete, Asphalt Concrete and Steel.

Description of major assignments and examinations:

- Several Homework Assignments: Homework is due at the end of the class one week after it is assigned. Late homework will not be accepted, and will not be graded.
- Two mid-term exams will be administered.
- One comprehensive final exam will be administered. All exams are closed book and closed notes, unless otherwise directed by instructor.
