## **INTERNSHIP** Spring 2015 Syllabus

Prerequisite: Must be a junior or senior and receive permission from instructor.

- **Description:** The Internship course is designed to give students practical experience in a variety of music media and music business settings. The student must work with a local business for at least ten hours per week (150 hours total).
- **Office Hours:** Thursdays from 1pm-2pm and I am also available at other times by appointment (contact me via email).

Attendance: see Assignment.

**Assignment:** Students must bring a signed letter (not an email) from their employer within the first two weeks of the semester detailing their job description and projected number of hours spent working per week (ten hours per week minimum). They must also bring a physical, signed letter (not an email) from their employer at the end of the semester detailing their work history and amount of hours spent interning. Students must also keep a journal with one entry per week briefly outlining their activities. This journal, along with the final letter from their employer, must be turned in to the Area Coordinator of the Music Media/Music Business Department by 12pm Friday of the week before finals.

Grading: Pass or Fail

Student Learning Outcomes: After successfully completing this course, students will:

- Have a firmer grasp of how the music business operates in the real world
- Have made connections with other audio professionals in the Dallas/Fort Worth area

**FINAL REVIEW WEEK:** A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
