Course Description

Course involves guidance of a graduate student's thesis research and writing as well as coordinating discussion with and feedback from other members of the student's thesis committee.

Course Objectives

By the conclusion of this course, it is expected that the student will have:

- Completed data collection required for a thesis on a communication topic.
- Thoughtfully analyzed the data in light of the student's selected theory/theories.
- Written a thesis paper that provides theoretical and academic literature foundations for the study, indicates the significance of the study, explains the methods used to conduct the study, and discusses the findings in a way that demonstrates a significant contribution to the field of research.

Tentative Course Schedule & Due Dates

The professor will meet with the student as needed. The student should adhere to the following deadlines:

- Apply for graduation by Feb. 2, 2015
- Complete research and begin analysis

March 2015

- Complete analysis and writing
- Submit first draft to committee chair for feedback
- Update thesis with revisions from chair

April/May 2015

- Hold defense by mid-April
- Update with revisions from committee feedback
- Send to thesis to library for first mechanical check by April 24
- Send approved thesis to library and paperwork to Admissions by May 8

Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless*

specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures: Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit, which is located at the end of the hallway in either direction from the classroom.
