Course Description

A continuation of CTEC 2350. This course provides in-depth examination of usability, accessibility, online rhetoric, and branding. Content also includes current Web communication technology including markup language, scripting and style sheet, for effective communication on the Web across multiple technological platforms.

Student Learning Outcomes

After completing the course, students will have demonstrated proficiency in creating usable, attractive, accessible, interactive web pages through the use of HTML, CSS, and basic JavaScript. Multiple assessment methods will be used to evaluate student performance and growth, including assignments, quizzes, in-class activities, exams, and a Web design project.
