Speculation & World Building:

Presenting a convincing world means that you have to be convincing. "Speculation & World Building" will consider some of the ways we imagine a world other than ours, how we argue for and describe it in order to better understand what sorts of arguments are successful and what "successful" means. Readings will be various and may include work from rhetorical theory, design and human/computer interface theory, literature, design fiction, and new futurism. Class time will be divided between seminar discussions and studio work and will consist of both solitary and collaborative projects (some writing, some making and building) with other students in our course and at TCU and Alma College, where related courses are being offered. Our common project is <u>Trapeñia</u>.

Projects:

Critical Tumblr-ing

Mostly, people post stuff on Tumblr because they like that stuff. Often, the page has a focus to start with. Sometimes, these posts start to create a context or focus outside of what the blogger intended. Use your course Tumblr account to gather anything course-topical that you find interesting and follow others in the course, too. It's a different, public way of taking notes and keeping track of inspiration. See what happens. Also, do the below for a grade.

Make a minimum of one course post a week (title it COURSE POST #: SOME SNAPPY TITLE HERE) with the following criteria. Each of these posts must consist of a minimum of

- 1. two images
- 2. either a link or a quote relating to or commenting on the image(s)
- 3. a text box in which you make clear the connection(s) to the course readings and/or "world building" as we're discussing it.

Your post may be in response to someone else's post, but you cannot repost someone else's image who is in the class. We'll have a master list so that we can all follow each other.

We will discuss some of the most engaging or thought-provoking of these Course Posts as a group.

Speculative Archaeology - Kickstarter

Find a Kickstarter project that hasn't closed yet, that addresses our wants or desires or needs in some way, and that you find particularly engaging, promising, funny, sad, whatever. Be prepared to present it to the class and make an argument for what's special and deserving of attention therein (in 5-10 minutes).

After these presentations, you'll use class responses and discussions to choose ONE of these Kickstarter projects to use for the assignments below.

1. in conjunction with the Actual World

a. Pull together the information the pitch gives you. What need or desire is the project addressing? What do the different levels tell you of the organizers' expectations of audience? What do the actual numbers of backers at each level tell you? Do you think it will be funded? Why or why not? Write this up as a report to be presented to the rest of the class (with slides, etc.).

b. Trace an incremental, speculative history for it. In 6 steps, extending 300 years back (so, from 1716 or so), trace the evolution of the technologies, innovations, societal changes, etc. that made the proposed project possible. Make charts, timelines, reenactments, whatever. Make it historical. Consider using sound elements in your work.

2. in conjunction with the Other World

Now trace an *alternative* incremental, speculative history for a new version of the artifact. In 6 steps, extending 300 years back (so, from 1716, or however they count in Trapeñia), trace the evolution of alternate technologies, innovations, societal changes, etc. that would make the "real" project different or impossible. Make charts, timelines, reenactments, whatever. Make it "historical." Be sure to update the <u>Trapeñia wiki</u> with your information.

The final project should take the form of a design fiction (as generally understood) and may take a variety of forms: prototypes and sketches, print advertising series, "serious academic article," product video, soundscape or audio tour, etc.

Feel free to work and present solo, or to combine your efforts with other students in the other courses whose subjects or explorations overlap your own in potentially interesting ways.

Grades will be determined via a modified version of The Learning Record. There will be a midterm portfolio and a final portfolio in which you will write summary interpretations and evaluations of your development in the course based on specific criteria and with specific examples from your work.
