Specific Outcomes of Instruction: Students will demonstrate an understanding of engineering properties of materials generally used in the CE/Constructional applications. Due to the time restraint, only the following materials will be discussed in this semester: Wood, Aggregates, Cement Concrete, Asphalt Concrete and Steel.

Required Textbooks: *Materials for Civil and Construction Engineering*, Third Edition, by Michael Mamlouk and John Zaniewski, Pearson Prentice Hall, 2011. ISBN 0-13-611058-4

Description of major assignments and examinations:

- Several Homework Assignments: Homework is due at the end of the class one week after it is assigned. Late homework will not be accepted, and will not be graded.
- Two mid-term exams will be administered.
- One <u>comprehensive</u> final exam will be administered. All exams are closed book and closed notes, unless otherwise directed by instructor.

Attendance Policy: At the University of Texas at Arlington, taking attendance is not required. Grading: Homework (15%), Exam 1 (25%), Exam 2 (25%), Final Exam (35%).

Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional $\underline{6 \text{ (six)}}$ hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.
