**COURSE DESCRIPTION:** Human geography is a field that involves the study of the spatial distribution and spatial relationships of human activities on the earth's surface. It involves a wide array of subjects and approaches that tend to intersect with other social science disciplines. We will read about and discuss many of themes current in the field. These include geographies that are cultural, political, historical, economic, social, and so on. The course is designed to introduce you to these various ways of studying the geography of human activities and to relate the many ideas and concepts of human geography to your life and the world around you.

7. Understand the ways in which binary terminology and thinking (e.g., local-global, us-them, male-female, society-nature, truth-fiction) shapes our conceptions of geography and the spaces of our everyday lives.
8. Analyze concepts and methods employed by human geographers to understand the spatial dimensions of nature, environment, culture, economics, politics, history, sociology, demography, and other social, scientific, and humanistic fields of study.
9. Apply written, oral, and visual communication skills to the analysis, evaluation, and synthesis of geographic themes and visual media.
10. Analyze, evaluate, and synthesize quantitative and qualitative data on the themes of human geography and critique the use of these data for representing geographic realities.
11. Interpret and evaluate the moral implications of themes in human geography and the relevance of human geography for developing the knowledge, skills, and values essential to intercultural competence, civic responsibility, and community engagement.

### **ATTENDANCE**

You will not be successful in this course if you don't attend class meetings.**

### **GRADING POLICY**

Your final course grade will be calculated as follows: Midterm Essay Exam (25%), Final Essay Exam (25%) Discussion Outlines (25%), and Attendance & Participation (25%). Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels. ### **DROP POLICY**

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
