## Section Information: PS 3318 (001)

**COURSE DESCRIPTION:** Major forms of psychopathology. Assessment, classification, etiology, and treatment of major disorders.

**STUDENT LEARNING OUTCOMES:** To understand basic concepts related to the history, theory and research in abnormal psychology and to gain basic writing skills at the level of an undergraduate psychology course.

## **REQUIRED COURSE MATERIALS:**

-MindTap is available on the main Blackboard menu under the "Cengage" link. There are also several documents in the "Course Materials" link that provide general instructions for MindTap, and how to disable pop-up blockers in Chrome and Firefox. MindTap is both an online version of the text and resources (quizzes, etc.).

-Selected research articles and other supplementary sources (provided in PDF form on Blackboard)

-Required Course Clicker: i>clicker 2. You will not be allowed to use "i>clicker go" or "REEF" on your own device, you must purchase i>clicker 2. You must register your clicker in Blackboard by Thursday, September 1<sup>st</sup>. Clickers can be registered by entering the 8-character remote ID (located on the back of your clicker) into the i>clicker Remote Registration link in Blackboard on the left sidebar. Clickers will be used in class for quizzes, attendance and participation. Clicker use counts towards your final grade.

-Blackboard: Much of the course material will be made available online at Blackboard. I do not put the lectures online before class, but will post after. The information you are provided in lecture is always more detailed than what appears online. You can obtain information about the Blackboard system at the help desk at the library (<u>helpdesk@uta.edu</u>). I will make announcements and distribute material via the class email list and the Blackboard class website as well.

-ClassRev Video Capture: Lectures will be recorded through UTA's ClassRev Video Capture system, and video links will be available on Blackboard. Viewing video lectures is not a substitute for attending class, and I can't guarantee that the system will always be functional. Videos will be made available at my convenience.

# **ASSIGNMENTS AND GRADING:**

Attendance/Participation: Attendance and participation in lecture will be determined by i>clicker use. Students will be allowed to miss three unexcused classes and receive full credit for attendance. Those who miss more classes will have points deducted from their attendance grade.

#### Exams:

There will be 4 multiple-choice exams given over the course of the semester as noted on the class schedule. The exams are based on the assigned readings, lecture content, and class activities. The last exam is not cumulative. You are allowed to drop one exam grade for the semester. If the class would prefer three exams we can discuss it, but most students prefer 4. The exams will be given online on Blackboard with no backtracking allowed. Exam periods will last several days. Therefore, there will be no make-up exams. If a student encounters an error when taking an exam on Blackboard they must contact me immediately. I will not re-set an entire exam if you have completed most of the items. You will be allowed to complete the unfinished items in-person only. *If a student prefers, he or she can take any exam in person.* 

#### Quizzes:

There will be 1 quiz per 2 book chapters (8 quizzes total). Each quiz will contain 5 items. You will use your i>clicker to submit your answers in class. You will receive 2 points for taking the quiz and an additional point for each correct answer (7 total points possible). Quizzes will begin on September 6<sup>th</sup> and the other quiz dates are listed in the Schedule at the end of the syllabus. You will be allowed to drop one quiz grade.

#### Written Assignment: Diagnostic Project

The theme of the written assignment is a diagnostic project. Students will select a popular (famous) or well-known historical person who is known to have psychological problems. They will research this famous person and identify his or her diagnosis using the diagnostic rules described in class and in your textbook. **Specific details (including assignment guidelines and a grading rubric) will be reviewed in class and posted on Blackboard.** 

**<u>Grading</u>**: Your grade will be based on your class participation, performance on the quizzes, written assignment and the three highest exam scores as shown below:

Missed work and attendance can be made up if the student has an appropriate excuse and accompanying documentation. Any missed work (exams, etc.) will be counted as a zero in final grade calculations.

**Extra Credit:** There will be two opportunities for extra credit in this course. The first involves submitting brief video clips to the professor for use during lecture. Clips should be approximately two minutes in length and should not be offensive. The preferred content will be depictions of course concepts in popular cultural forums such as film, television, literature or music. Students should not submit clips that reflect course concepts that we have already covered. Students are only allowed to submit (and receive credit for) one clip per week. The general idea is to have something fun to share with the class that relates to our course as a break from lecture. The second extra credit opportunity will be a brief paper assignment that will be graded pass/fail. The content of the extra credit assignment will be decided by mid-semester. Each total extra credit value is typically calculated as equivalent to 2% of the final grade (students can participate in both opportunities).

Attendance: At The University of Texas at Arlington, taking attendance is not required. Rather, each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, attendance and participation in lecture will be determined by i>clicker use. Students will be allowed to miss three unexcused classes and receive full credit for attendance. Those who miss more classes will have points deducted from their attendance grade. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

#### **Incompletes:**

Incompletes will only be given under extenuating circumstances and must be discussed with the instructor BEFORE the last day of the semester. The grade of incomplete will be assigned only if the student has encountered circumstances beyond his or her control and the student's previous actions have not created these circumstances. The assignment of this incomplete grade will be made at the decision of the instructor after consideration of the facts as presented in a written request from the student. An incomplete will not be awarded merely to allow more time to complete course assignments or to avoid an undesirable grade. Please do not ask me to do otherwise.

# POLICIES AND SPECIAL CIRCUMSTANCES:

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing.
