### Time and Place of Class Meetings:

This class meets online in Blackboard. While most class participation is asynchronous, some synchronous online activities may be scheduled.

### **Description of Course Content:**

Clinical management of the high-risk neonate using evidence based knowledge, research, pharmacological, and technological therapies. Focus on the following systems: skeletal, integumentary, immunologic, and neurologic. Includes clinical management of complex health problems affecting infants (birth to 2 years of age) and their families including chronic care and ethical issues.

### **Other Requirements**:

Prerequisite: NURS 5537. As this course is offered in an online format, **each student must have a computer with a high speed internet connection**. Students are required to have a headset (with microphone) and webcam to participate in web conferences and to test online.

Testing will be done online using Respondus browser and monitor (which students must download from a link within Blackboard and install on their computer). The instructor will determine what option is offered to students who are unsuccessful in completing a test online. Students may be required to complete an alternate version of the test using ProctorU for which students must pay a fee.

### <u>Student Learning</u> Outcomes:

- 1. Assess, diagnose, and plan for the management of health care needs of the high-risk neonate using evidence-based knowledge.
- 2. Use pharmacologic and technologic therapies in the management of the high risk neonate's complex acute and chronic illnesses.
- 3. Develop plans for health promotion and disease prevention in the care of the high-risk neonate within their family system.

If the author's ideas are rephrased, by transposing words or expressing the same idea using different words, the idea must be attributed to the author by proper referencing giving the author's name and date of publication. If a single author's ideas are discussed in more than one paragraph, the author

must be referenced, according to APA format. Authors whose words or ideas have been used in the preparation of a paper must be listed in the references cited at the end of the paper.
