Description of Course Content: Review of the diatonic system and secondary functions; introduction and study of modulatory procedures, simple sectional forms, mode mixture, and the Neapolitan and augmented sixth chords. Exercises will involve part-writing and harmonic and formal analysis.

Student Learning Outcomes: Upon completion of this course, students will be able to produce a composition that demonstrates a mastery of sectional forms, modulations, modal mixture, and Neapolitan and augmented sixth chords, as well as to produce a cogent and accurate analysis of a musical composition or excerpt that contains these elements.

Attendance: At The University of Texas at Arlington, taking attendance is not required. As the instructor of this section, I have established the following policies.

Absences: See attendance grade above. <u>More than 5 unexcused absences (including the</u> <u>'freebies') may result in automatic failure</u>. Any absence, no matter the reason, other than Dean of Students-excused absences or medical emergencies, are UNEXCUSED (this includes illness, traffic-related issues, alarm-clock failures, no matter how "reasonable" it seems to you). Notifying Dr. Hunt about why you were absence is appreciated as a courtesy, but will have no bearing on you being counted absent.

Assignments must be turned in on the due date at the beginning of class. In other words, if you are late to class, your homework will be counted LATE. Late assignments will lose a letter grade (i.e. 10 points) for each day that they are late; this includes days between classes—weekends count as two days. Assignments more than a week late will not be accepted. All quizzes and exams must be taken on the scheduled date and time; make-up exams will only be given with a doctor's note or a letter from the Student Affairs Division. It is your responsibility to understand all aspects of the Attendance policy, and to keep track of your absences should they pile up. I will not necessarily give you any warning if you are approaching or at the limit.

Be in class on time. You are responsible for any rescheduling of assignments or class material you miss because of lateness or absences. Chronic lateness will not be accepted and will result in a mandatory conference with the professor.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. Drops can continue through a point two-thirds of the way through the term or session.
