249 - Partner Lessons, individually assigned times 258 - Studio Class at 3:30pm-4:30pm on Friday, Performance Majors stay for a second hour (Performance Class)

Description of Course Content: Applied flute lessons and studio class focus on all aspects of high quality musical performance including effective practice, excellent rhythm, beautiful sound, clear articulation, score study, listening, ensemble skills, intonation, pacing, stylistic awareness, stage presence and more. The specific course requirements are tailored by the instructor to meet the individual student's needs, but students of all majors and levels will be held to the same standard of *consistent improvement and thorough preparation*.

Student Learning Outcomes: Each student should demonstrate *consistent improvement and thorough preparation* in lesson performances, studio class, juries and recitals as applicable. As a result of the student's commitment to incorporating guidance provided in lessons and continuously developing his/her own musical ability through dedicated practice, he/she will be able to perform in a more professional and effective manner.

Required Textbooks and Other Course Materials:

- 2 Musician tools: recording device, metronome, tuner, flute cleaning materials (woodwind paper, etc.)

- 8 UTA Flute Studio Lesson Book (available at UTA Bookstore bring to first lesson of the semester)
- 9 *Presence*, by Amy Cuddy (available in most bookstores and Amazon.com)

Descriptions of major assignments and examinations:

- 1 All items described in the UTA Lesson Book must be completed throughout the semester, including Recital Attendance. Follow instructions found in the Lesson Book for saving programs and typing concert notes, to be turned in on Friday, December $2^{\rm nd}$.
- 2 Attendance at all scheduled lessons with individual assignments <u>thoroughly</u> prepared. Partner lessons enhance the learning experience by providing a more performance-oriented atmosphere, increased accountability, and the opportunity to learn about flute pedagogy. *Partners are assigned based on educational benefits and scheduling, not on student preference.*
- 3 Technique Jury held during Studio Class on Friday, November 11th (change from Lesson Book)
- 4 Performance in a jury or degree recital with all appropriate rehearsals arranged/attended.

Attendance: At The University of Texas at Arlington, taking attendance is not required. Rather, each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I expect 100% attendance at all required events with the only exception being illness, emergency, or academic conflicts with notice given when the conflict arises (i.e. not the day before an event when the schedule has been posted all semester).

Expectations for Out-of-Class Study: As many practice hours as it takes to meet or exceed expectations described by the instructor in this syllabus, the Fall 2016 Lesson Book, and during applied lessons.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures: Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit, which is the main music department stairwell. When exiting the building during an emergency, one should never take an elevator but should use the stairwells. INSTRUCTIONS: For each recital or event you attend, type the following information on a separate sheet of paper. Paper clip or staple a program from the event to your recital sheet. Stay organized and keep all your recital sheets and programs together so that you can turn them in during the last studio class of the semester. Bonus points will be given for professional/creative presentation. If you turn in complete information for all the required events (see above), than you will receive full credit for recital attendance. Each incomplete or missing recital sheet/program will lower your grade proportionally.

- 2) 3 observations, connections, and/or salient features for every piece on the program.
- 3) One personal improvement or reminder based on the event.

Example Recital Sheet (with Program Attached)

Taking good notes during the event will make typing your final version very easy.

1) Recital Attendance Requirement: UTA Flute Event

- 2) Piece #1: Prokofiev Sonata
- 1 I love the way the second movement is so guick and mischievous.
- 2 The fourth movement is very rhythmically driven and exciting.
- 3 I would love to play this piece next year for my recital!

Piece #2: Taktakishvili Sonata

- 1 The flutist's gorgeous, singing sound in the first movement was very inspiring.
- 2 It seems like intonation is of the utmost importance in the second movement.
- 3 The third movement is a great reminder to practice my chromatic scales!

Piece #3: Amirov Pieces for Flute and Piano

- 1 I was curious about Fikret Amirov and read in the program that he is Azerbaijani.
- 2 Listening to these movements made me want to seek out more pieces with folk like melodies.
- 3 I want to remember how drawn in I was by the joyful first movement so I can make a point of picking repertoire that does the same thing for my audiences.
- **3)** During this recital, I learned the importance of stage presence. I will remember to bow graciously and smile at the audience anytime I perform a recital.
