#### **Learning outcome for applied lessons**

The student will combine previously acquired knowledge of percussion techniques and experience advanced new techniques on all the following instruments:

- Mallet percussion
- Snare drum
- Timpani
- Drumset
- World percussion

The student will be evaluated in two ways. First by demonstrating knowledge through the successful performances excerpted from material studied throughout the semester, and second the synthesis of these new techniques into a successful musical performance on at least two instruments of the percussion family each semester during jury performance and UTA Proficiency Method Book List

## **1. Lessons**

Lesson material is divided into two categories: Performance and Technique proficiencies. It is the responsibility of the student to prepare an appropriate amount of material for **each** lesson. You will be tested each semester in both categories. Performance repertoire is tested with the final jury performance. Technical proficiency is tested at the end each semester by proficiency playing tests.

## Grade weight:

50% Studio Grade
40% Final Exam-Jury
10% Mid-Semester performance

Applied Lessons 50% Studio Grade breakdown:

- 70%: Weekly lesson preparation/improvement and attendance
- 20% **Proficiency success: passing number of attempted books**
- 10% Collegiality, concert attendance, care of equipment, Forum attendance and participation

Jury Breakdown:

- 45% first piece
- 45% second piece
- 10% sight reading (tested on proficiency date)**

*Lesson grades depend on the following:*

- Attendance,
  - Consistent weekly improvement,
  - Successful completion of proficiency material
    - You must sign up and attempt barriers each semester to receive a **passing grade** for applied lessons.
  - Midterm recital performance
  - Attendance and participation in weekly percussion forum,
  - Jury final exam.
- Since collegiality and team work play such a large part of the percussion area the final grade will also reflect teamwork including, but not limited to, concert attendance, participation in equipment moving, returning equipment to proper storage facilities and general participation in the day-to-day operation of the percussion area.*

- A. Lessons for majors are 50 minutes per week. Elective lessons are a half-hour per week. Lesson times are arranged with your instructor at the *percussion Forum* held the first week of each semester, 12:00-12:50.
- B. Students must perform at least one solo each semester on a percussion formal midterm recital. It is the responsibility of the student to complete each semester's performance requirement.
- C. The student must give early notice if he or she plans on not attending a forum, rehearsal, or lesson. **Absences will affect your overall grade.** After the first

- absence, each absence lowers the final grade one letter. Only University or medical excuses will be made up at the instructor's discretion.
- D. Percussion lessons cover every instrument in the field of percussion, usually concentrating on two different areas each semester such as Snare, Multiple Percussion, Timpani, Marimba, Drum set etc. Additional elective percussion lessons are available for percussionists wishing to specialize in a particular area.
  - E. Students must perform at least one **solo** each semester on a percussion formal midterm recital. It is the responsibility of the student to complete each semester's performance requirement.

## 2. Weekly Class Forum

Percussionists will attend a regular forum class held Mondays 12:00-12:50 in Room 226 or as announced. This **required** class is part of your semester grade and will include listening to recordings, performing, guest artists, and lectures on essential percussion techniques that can be covered in a group setting.

**If you have 3 or more un-documented absences from Forum your semester applied grade will be reduced 1 letter grade**

## 3. Practice

- A. You should practice a minimum of 2-3 hours a day consistently including weekends. This time should be spent in personal development. *Make sure you allot separate time to prepare for each ensemble you perform in.*
- B. Practice Facilities  
220,221,208,226, 227,228, 113C, 367G, Room 226 Ensemble room, Band Hall (Room 115) Timpani and Percussion (Room 115 closed after 5:00, and during scheduled classes. Check main office for available times).
- C. You must bring a receipt for the \$25.00 *Instrument Usage Fee* and be signed up for lessons in order to gain access to the practice rooms with your ID card

## 4. Equipment

- A. Equipment belonging to the Percussion Department is your responsibility and you are expected to take care of it as if it were yours. Equipment that does not belong to you or the University is to remain untouched. Do not borrow, move, or practice on privately owned equipment unless you have permission to do so.
- B. If you need to move any equipment from one assigned area to another, return it to its proper storage. Repeated failure to do so will cause you to be denied use of the facility
- C. **Do not move equipment from the music Building without permission. Request permission through the equipment manager**
- D. Shelves in the percussion rooms are labeled. Make sure each item is returned to its proper area.
- E. Whenever you leave the building, take a moment to think if you put everything away. Also, if you see something left out, be a Samaritan and put it away in its correct place. If an instrument is misplaced we all suffer no matter who left it out.

- F. The Percussion Manager is:  
If there is a problem, speak to him/her about it. Be professional however; if it is something small you can fix go ahead and fix it. Playing is more enjoyable when the equipment is in good repair.
- G. Put covers back on when you are finished.
- H. Follow the general rules of good teamwork: if you move something-return it, if you break something-fix it, if something needs done-do it.

## 5. Percussive Arts Society Membership

The percussive Arts Society is perhaps the very best source of information for percussion professionals. Your membership includes magazine subscriptions, newsletters, and local, regional, national, and international activities in all aspects of percussion. Your membership must be renewed yearly. You must show your membership card indicating active status prior to receiving a grade each semester.

## 6. Performance Attendance

It is expected that each percussion student attend a reasonable amount of orchestra, band, wind ensemble, percussion ensemble and jazz band performances. In addition to the valuable knowledge that can be gained from listening to live performances it is a nice way to support your peers and it is a reflection of the spirit that epitomizes cooperation and a strong work ethic within the percussion program. Students are expected to attend public performances by percussion guest artists, significant professional ensembles and UTA percussion Faculty.

## 7. Proficiency Requirements/Protocol

### General Information

The purpose of a Proficiency test is to demonstrate the student has learned and retained all the pertinent skills worked on during the semester to perform at a high level, and that the student has the facility and skills necessary to successfully move forward to the next semester of study.

### Prerequisites

- Permission of the applied professor to perform based on semester grade
- The student must have successfully passed the previous proficiencies leading up to the skills required for the semester.

### Procedure

- The student MUST perform skills on all the books/areas agreed upon at by contract at the beginning of the semester or the final grade will be affected.
- The student is expected to bring all necessary books, mallets and grids to the proficiency. We will provide drumset, marimba, snare drum, timpani, vibe, and hand drums, but it is highly recommended the student bring their

own personal items whenever applicable such as snare drums, cymbals, etc.

- The Proficiency test is a 10-minute test consisting of Performing examples from the material ASSIGNED AND LISTED ON THE GRID for the semester. THIS TEST IS OVER ALL THE SEMESTER SKILLS LISTED ON THE “GRID” NOT JUST THE ONES THAT WERE HEARD IN LESSONS.
- Sign up time will be announced and posted for proficiency time
  - Each Student will sign up for a time slot, to allow for instrument set up, tear down, performance, and some verbal comments from the Proficiency panel. ***ALL PAPERWORK, SIGNUP’S, DOCUMENTATION, MUST BE COMPLETED BY 5:00 ON THE FRIDAY BEFORE PROFICIENCIES.***
- **Leave plenty of time to warm up**, and prepare both mentally and physically. Be early to be on time, and waiting outside the recital hall door. We are on a tight schedule.
- You will sign up for back to back time slots
- Wear appropriate attire for performance. Although more informal than a jury, appropriate attire is expected
- It is illegal to photocopy music you do not own. You must personally OWN the music... No borrowing
- This test is to demonstrate comprehensive accumulation of skills gained over the previous semesters. Scales, rudiments, and appropriate patterns WILL BE ASKED FOR.

***Although this is a “skills” test musicianship and musicality will be expected on all etudes.***

A Pass/Fail will be assigned for each Skill/Book Tested. This will be weighted/averaged to be added to the FINAL GRADE. **If you do not pass 50% of your contracted proficiencies your final letter grade will be reduced 1 letter.**

## 8. Jury Requirements/Protocol

### General Information

The purpose of a jury hearing is to demonstrate the student has learned and retained all the pertinent performance during the semester to perform at a high level, and that the student has the facility and skills necessary to successfully move forward to the next semester of study.

### Prerequisites

- Permission of the applied professor to perform based on semester grade
- The student must have successfully passed all assigned proficiency requirements of the semester before they will be allowed to take a Jury hearing.

### Procedure

- The student must perform on a two of the four percussion instruments that have been studied in the semester: drum set, marimba, timpani and snare drum.
- The jury hearing is a 10-minute jury consisting of:
  - 2 soli of significant music/technical content
  - Sight Reading
    - The two soli may not be on the same instrument.
    - Sign up time will be announced and posted for a jury time and proficiency time
    - Each Student will sign up for a time slot, to allow for instrument set up, tear down, performance, and some verbal comments from the jury panel.
- ***Sight Reading component: Sight reading is an essential skill that needs to be reviewed and improved each semester. Sight reading skills on Snare drum and Mallet instruments (and possibly others) will be tested each semester. 10% of the final jury grade will be devoted to sight reading. Sight reading will be tested on the proficiency date***
  - The sight reading will consist of material of similar level to what the student has been working on in the semester applied lesson but NOT material the student has prepared or seen before.
- Other jury details:
  - **Leave plenty of time to warm up**, meet accompanist, and prepare both mentally and physically. Be early to be on time, and waiting outside the recital hall door. We are on a tight schedule.
  - Wear appropriate attire for performance. Suit and tie in most instances.
  - Review stage etiquette sheet. You are evaluated on this aspect also.
  - Have the original and 1 copy of your music, and your repertoire sheet (typed) available for the jury. You must present **the original**

**copy** of all music you will be performing. It is illegal to photocopy music you do not own. You must personally OWN the music...

No borrowing

- You must show your membership card indicating active status at the time of your jury
- Repertoire sheets are available by email. **No sheet, no performance.**

A grade will be assigned for each of the two soli. The two grades will be weighted and averaged to arrive at the total JURY GRADE.

You will be able to review your jury sheets with your professor later. After the semester they will be on permanent file in the advisors office.

*We will hold originals and music copies for you until the beginning of the next semester at which time they become university property.*

## 9. Sophomore Hearing

### General Information

The purpose of a sophomore hearing is to demonstrate the student has learned and retained all the pertinent performance requirements up to the 4<sup>th</sup> semester and that the student has the facility and skills necessary to successfully complete the course material of the upper level semesters.

### Prerequisites

- The student must have successfully passed all assigned proficiency requirements of the first 3 semesters before they will be allowed to take a sophomore hearing.
- If the student has not passed all the proficiencies for 1250,1251,2250 by the end of their fourth semester they will receive a grade of F for the semester and repeat 2251

- The student must have achieved a grade of A or B in the Studio/Mid Semester Jury portion of the applied lessons grading scale before they will be allowed to take the hearing.

Applied Lessons Grading Scale

50% Studio Grade

1. Proficiency
2. Weekly Lesson Grade/attendance

4. Collegiality, concert attendance, care of equipment

40% Final Exam-Jury

Jury Breakdown:

45% first piece

10% Mid-Semester performance

## Forum Presentation

Each student in the Sophomore Hearing 2251 semester shall present a “clinic” at the weekly Percussion Forum Class, Monday 12:00-12:50. The subject must be submitted and agreed upon by the Applied Professor.

The parameters for the project are:

1. Must last 50 minutes
2. Must include a handout, with musical examples, and with citations (After the applied faculty has **approved** the handout the student will copy and supply it to the studio members)
3. The Clinician must perform a high percentage of the time in the clinic
4. The clinician must utilize audio and visual elements in the presentation
5. The clinician must utilize/teach members of the class when appropriate

## Procedure

- The student must observe all the protocol and rules concerning Juries as set forth in all juries for the previous 3 semesters. (Please see *Jury requirements and Protocol*)
- The student must perform on all four percussion instrument areas that have been studied in the previous semesters: drum set, marimba, timpani and snare drum.

The sophomore hearing is a 20-minute jury consisting of:

**Performance**

2 soli of more extensive music/technical content than previous semesters. The two soli may not be on the same instrument.

Must perform 1 etude, a study of shorter duration filling out the third area

**Scales /Rudiments** (performed from memory)

1. Major



2. Minor (Natural, Harmonic, Melodic)
3. Format -16<sup>th</sup> notes, 2 octaves up and down Q=at least 76
4. The Standard 40 PAS drum rudiments. All must be performed slow- fast- slow (open-closed-open) taking no more than 40 seconds per rudiment. Must achieve at least the marked tempi of the proficiency requirements.

### Verbal Test

A study guide will be given out at the beginning of the 2251 semester listing some sample questions. The jury will ask questions on information including;

- Percussion history
- Instrument details, dimensions, transpositions
- Literature information
- Specific detailed presentation on the history, theory, of the three pieces performed.
- Knowledge of teaching basic percussion skills

### Grading

If the student passes all parts the sophomore hearing they move on to level 3250

If the student fails to pass all three portions of the sophomore hearing they are retained in course 2222 which allows the student to work on deficient skills to prepare to pass the hearing the following semester. The student will receive a grade of Incomplete for 2251.

At the end of the 2222 semester two possible outcomes would be:

The student passes the required portions that were previously failed. They will now be allowed to register for 3250 the following semester. In addition, the previous grade of incomplete will be changed to an appropriate letter grade.

The student fails (second time) the required portions that were previously failed. The student **will not be allowed to remain a music major.** To continue as a music major, the student will be required to re-audition.

## 10. Final semester Capstone Project

All Percussion students, regardless of degree plan, will, with the instructor's guidance and approval, select, develop and carry out an appropriate performance project in their final semester of study. *(For performance majors, the requisite degree recital sufficiently meets this requirement.)*

The purpose of this project is to give structure and purpose to the final semester of private study. Possible options for this requirement are endless; please consult with the instructor at your earliest opportunity to design a project satisfying your interests as well as the studio's requirement.

1. Unless agreed upon by percussion faculty the capstone project will be a half recital (25minutes of music minimum) performed in the semester of the capstone project grade. It is the student's responsibility to present a

list of proposed pieces for the recital to the percussion faculty for approved.

2. ONLY APPROVED PIECES WILL BE ACCEPTED FOR THE PERFORMANCE
3. All other weekly grades, forum attendance, and mid-semester performances are still part of the student's grade responsibility.
4. It is the student's responsibility to speak with the Hall Manager and determine a list of possible recital dates. Then present them to the percussion faculty to be approved.
5. **3 weeks before the Capstone recital the student must perform a "pre-recital hearing" for the percussion faculty to be graded and receive final permission to present the recital. This can take place in 226 but must be scheduled by the student through the percussion faculty.**
6. A final recital program listing all the performed pieces in the appropriate program decorum (available from the Music Office) must be presented to the Percussion faculty at least 1 week in advance of the recital. It is the student's responsibility to get the programs printed and posters placed around the music department announcing the recital.
7. Appropriate attire, stage presence, decorum, are all part of the final grade.
8. Upon successful completion of the Capstone Project the student is not required to present a jury. The recital counts as the semester jury.

Specific semester assignments can be changed with permission of Percussion faculty. However every student **MUST** have studied and **passed** at least one semester of drumset, mallets, snare drum, and timpani **BEFORE** attempting a Sophomore Hearing

### **University Based Policies:**

**Campus Carry:** Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. **Final Review Week:** A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
