**Prerequisite:** Must be a junior or senior and receive permission from instructor.

**Description:** The Internship course is designed to give students practical experience in a variety of music media and music business settings. The student must work with a local business for at least ten hours per week (150 hours total).

**Office Hours:** Office hours are available by appointment (contact me via email).

**Attendance:** see Assignment.

**Assignment:** Students must bring a signed letter (not an email) from their employer within the first two weeks of the semester detailing their job description and projected number of hours spent working per week (ten hours per week minimum). They must also bring a physical, signed letter (not an email) from their employer at the end of the semester detailing their work history and amount of hours spent interning. Students must also keep a journal with one entry per week briefly outlining their activities. This journal, along with the final letter from their employer, must be turned in to the Area Coordinator of the Music Media/Music Business Department by 12pm Friday of the week before finals.

**Grading:** Pass or Fail

**Student Learning Outcomes:** After successfully completing this course, students will:

- Have a firmer grasp of how the music business operates in the real world
- Have made connections with other audio professionals in the Dallas/Fort Worth area

**DROP POLICY:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **FINAL REVIEW WEEK:** A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
