Description of Course Content: An introduction to the scientific study of human language, using English as an example. Topics in the course include how sounds are produced, how words and sentences are structured, how and why language changes, how language is acquired by children and adults, how the brain processes language, and how language and society intersect.

Course Objectives: The goal of LING 2301 is to change students' relationship with language by challenging and enriching thinking about language and raising consciousness of the role that language plays in the minds and communities of humans. As the semester progresses, students should be increasingly prepared to enter into well-informed discussions about the primary themes of the course:

- 1. All languages are systematic, manifesting the complementary properties of rule-governance and creativity;
- 2. Language acquisition and use are rooted in both cognitive (internal) and social (external) factors; and
- 3. Languages reflect both our collective humanity and our socio-historical diversity; as such, all languages are worthy of study and respect.

These course themes are supported by reference to specific topics as covered in the readings, lectures, and class discussions.

Student Learning Outcomes: Upon successfully completing this course, students should be able to:

- Identify and explain many of the basic questions investigated by linguists, in order to situate the discipline of linguistics in the broader intellectual landscape [Critical Thinking Skills objective]
- Describe and illustrate the features shared by all languages, in order to distinguish those aspects of human language attributable to genetics/biology from those that are socially conditioned landscape [Critical Thinking Skills objective]
- Analyze communicative signs (icons, words, sentences), in order to differentiate form, meaning, and function within a sign and to justify the use of a particular form in a specific context [Communication Skills objective]
- Compare the characteristics of normative and non-normative/developing language behaviors in order to recommend appropriate measures when interacting with language-limited individuals (especially children and aphasic adults) [Empirical and Quantitative Skills objective]

- Analyze the structure of interpersonal interactions, in order to assess the ways in which language both reflects and creates social relationships [Social Responsibility objective]
- Identify major historical events that have shaped modern (American) English, in order to explain contemporary patterns of language use and sociolinguistic attitudes [Empirical and Quantitative Skills objective]
- Debate the relative merits of monolingualism vs. multilingualism, in order to make more informed decisions about relevant social, educational, and legal policies. [Social responsibility objective]

These student learning outcomes align with the following four Texas Higher Education Coordinating Board objectives:

Critical Thinking Skills: To include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information.

Communication Skills: To include effective development, interpretation and expression of ideas through written, oral and visual communication.

Empirical and Quantitative Skills: To include the manipulation and analysis of numerical data or observable facts resulting in informed conclusions.

Social Responsibility To include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national and global communities.

Descriptions of major assignments and examinations: Over the course of the semester, students will complete the following assignments and exams:

- Homework Assignments: Eight (8) regular homework grades will be given over the course of the semester. Regular homework assignments will assess the student's ability to apply terms and concepts OR prepare them for future lectures or assignments. The average homework assignment grade accounts for 35% of the final grade.
- Signature Assignments: Two (2) larger assignments, the Second Language Interview Project and the Oxford English Dictionary Exploration Essay, will be given out in Units 2 and 3. Signature assignments will require students to collect data and craft an essay based on the data. Each signature assignment accounts for 7.5% of the final grade (15% combined).
- Quizzes: A number of in-class pop quizzes will be given over the course of the semester. Quizzes will be administered during the first or final five minutes of the class meeting. Pop quizzes may cover the required reading, previous day's lecture, or current day's lecture. The lowest two (2) quiz grade will be dropped. Make-up quizzes will **NOT** be allowed, and students arriving late will **NOT** be given additional time to complete quizzes. Quizzes account for 10% of the final grade.
- In-class Exams: Two (2) in-class exams will test the student's knowledge and ability to recognize and apply terms and concepts. In-class exams will independently cover materials from Units 1 and 2. Each in-class exams account for 10% of the final grade, (20% combined).
- Final Exam: The final exam will be cumulative and will test the student's knowledge and ability to recognize and apply terms and concepts covered since the beginning of the semester. The final exam accounts for 20% of the final grade.
- Extra credit: Students can earn extra credit by attending approved colloquia or local conference presentations, participating in linguistics lab experiments or studies, or completing an end-of-semester extra credit assignment. Details and requirements for extra credit opportunities will be provided as they become available. The maximum extra credit a student can earn is 3%.

Late Assignments: Homework and signature assignments will **NOT** be accepted late (automatic zero). Each students may request a maximum of two (2) assignment extensions over the course of the semester. Students requesting an extension **must email the instructor no later than 5:00 pm the day before the assignment is due**. Approved extensions will give the student 48 hours to complete the assignment.

Make-up Exams: A student will be allowed to take a make-up exam only if the absence occurs as the result of an extreme and reasonably unforeseeable circumstance (e.g. sudden serious illness, major family crisis). Should this occur, the student must contact the instructor by phone or e-mail before 5:00 p.m. of the exam date to request a make-up. Students who miss an exam but do not notify the instructor as specified above will receive a grade of zero (0).

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I have established the following attendance policy:

- Attendance will be taken at the beginning of class.
- Failure to attend a class session will count as one (1) absence.
- Arriving late (after lecture/discussion has begun) OR departing early will incur a half (1/2) absence. Students who arrive late should check-in with the instructor at the end of class to be marked as present, else they will be marked as fully absent. Students who need to depart early should notify the instructor at the beginning of class.
- If a student has six (6) or fewer combined absences AND has turned in all homework and signature assignments, then that student will have their lowest regular homework score dropped. (This **CANNOT** be applied to a signature assignment grade.)

However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Grading: Final grades will be calculated based on the weighted average of assignments provided below:

Extra credit will be added after the weighted course grade has been calculated, e.g., 78% weighted grade plus 2.5% extra credit would result in an 80.5% for the course.

Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels; see "Student Support Services," below.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
