Purpose and content of the course: This is the first part of graduate level Quantum Mechanics course. This course will introduce and discuss a formal mathematical and physical structure of Quantum Mechanics. It is expected that the students know the undergrad level quantum mechanics and have some familiarity with the concept of linear vector space. The content of the course is about first four chapters of the main text book.

Home Work: Home work will be assigned periodically. Solutions will be available after the due dates. Every other week, there will be a class devoted to the discussion on home works. Start working on the HW early. No late submission will be accepted. **Also, no make-up HW will be assigned.**

Exams: There will be two exams: one is midterm and the other is final. Both exams will be of equal weight. One of them will be an in-class exam.

Mid-term exam date: 08/19/16.

Final exam: 12/14/16.

There will be no make-up exam.

Attendance: Attendance in the class is highly encouraged. However, if you missed class/classes it is your responsibility to know what/when the HWs are given or if there is any change of plan.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
