Attendance:

Attendance will be taken regularly and missed class work will not be graded. You are expected to sign in using the attendance sheet that will be provided when as you enter the class. You must carry your UTA ID (MAV Express) card with you to class. Timely attendance in this class is expected. It is important that class be started on time and proceed with minimal interruptions. Arriving more than 10 minutes late will count as an absence. You will also be required to sign out of class if you leave the classroom for any reason before the end of class. You will receive 5 points for arrival on time. You will lose 2 points for early departure from class.

If you are dropped from this class for non-payment of tuition, you may secure an Enrollment Loan through the Bursars Office. You may not continue to attend class until your Enrollment Loan has been applied to outstanding tuition fees.

Drop Policy:

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. Students will not be automatically dropped for non-attendance. Final Review Week:

A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
