Catalogue Course Description:

This course focuses on the development of reading, writing, speaking and listening skills in Spanish, as well as an understanding of Hispanic cultures and issues of identity of heritage speakers in the United States. This course is intended for heritage speakers of Spanish and is an appropriate substitute for Spanish 2314. Prerequisite: Spanish 2313 or the equivalent.

Student Learning Outcomes:

Upon the successful completion of the course, the student will demonstrate:

- an improved ability to read and understand texts written in Spanish
- an improved ability to converse in Spanish about cultural topics
- an improved ability to write formally in Spanish
- greater knowledge of spelling and accent rules in Spanish
- a better understanding of basic Spanish grammar, especially with respect to uses and conjugations of verb tenses.

Attendance and participation: Class attendance is mandatory. Students are expected to participate actively in class discussions; their participation should reflect having done the assignments and completed the assigned readings for the class period. Students will receive a daily participation grade that ranges from 0-3. Students are allowed three (3) absences during the semester. For any absence above three (3), a grade of zero (0) will be averaged into the student's participation grade.

Homework and short quizzes: During the semester, students will be assigned seven (7) assignments on verb forms (Tarea 1-7). (See packet and instructions on Blackboard.) No late homework, nor homework turned in via email, will be accepted, but the lowest grade will be dropped at the end of the semester. The dates for the short quizzes, which will be on verb forms, will be announced one class day in advance. No make-up quizzes will be offered, but the lowest grade will be dropped at the end of the semester.

Workbook: Students will do activities from the *Manual de actividades* and will hand them in on Exam days (see dates below). No late work will be accepted.

Essays: Students will write two formal essays in class and will revise their essays, incorporating instructor feedback.

Chapter exams: There will be an exam on Chapters 1-2 and an exam on Chapters 5-6.

Midterm exam: The midterm exam will include material from Chapters 1-4.

Examen final: The final exam will include material from Chapters 5-8.

<u>Note on all exams</u>: Exams will cover material from the textbook, workbook, class activities, plus any supplemental material. No make-up exams will be given.

Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures: Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit, which is located straight ahead as you exit the classroom. When exiting the building during an emergency, one should never take an elevator but should use the stairwells. Faculty members and instructional staff will assist students in selecting the safest route for evacuation and will make arrangements to assist individuals with disabilities.

More information:

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I have established the attendance policy described above (see "Attendance and participation"), to wit: I take attendance on a daily basis, and students are assigned a daily participation grade, which is factored in the "Attendance and participation" portion of the final grade. Any absence above three (3) will negatively impact this portion of the grade. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

<u>Grading</u>: The final grade for the course will be calculated by adding the average grade the student receives in the categories mentioned above in "Evaluation": Attendance and participation (10%); Homework, workbook, and short quizzes (20%); Essays (10%); Chapter exams (20%); Midterm exam (20%); Final exam (20%).
