Course Description:

Advanced study of electromagnetic theory, its content, methods, and applications. Topics include theorems in electromagnetic theory, cylindrical and spherical wave functions, waveguides, integral equation methods, scattering and diffraction.

Objective: This course is designed to give you an understanding of the basic properties of

electromagnetic waves, methods of solution for exterior and interior problems in electromagnetics, and applications of electromagnetic theory. After completing the course, you are expected to have the ability to develop a mathematical model, construct solutions, and analyze the electromagnetic waves inside and outside of a

canonical structure.

Lecture Topics (plan): This course will cover selected topics from Chapter 1 through Chapter 7,

Chapter 11 and Chapter 12 of the required textbook.

Key topics include:

- Large scale (integral) and differential form of Maxwell's equations

- Boundary conditions and power flow

- Time-harmonic Maxwell's equations

- Solutions of Maxwell's equations inside and outside of canonical structures

- Wave propagation and polarization

- Reflection, transmission, scattering, and radiation

- Electromagnetic theorems

- Guided waves: transmission lines, rectangular and cylindrical waveguides

- Antennas and radiated waves

- Integral equations and method of moments: EFIE, MFIE

- Selected applications in wireless systems and radar remote sensing

# ------ IMPORTANT INFORMATION ------

#### Attendance:

At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I will take attendance sporadically. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

## **Drop Policy:**

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. #### Final Review Week:

A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
