Description of Course Content: This course introduces the fundamental goals and techniques of syntactic analysis from the perspective of Generative Grammar. It also has the goal of putting you in a position to pursue more advanced study of the structure of human languages and to provide a foundation for your own research.

Student Learning Outcomes: Upon successfully completing this course, students should be able to

- 1) understand theoretical concepts and tools in syntax.
- 2) apply these concepts and tools to the analysis of a wide range of languages.
- 3) understand of how to make coherent arguments and provide empirical justification for theoretical claims.

Descriptions of Major Assignments:

Problem Sets (80% of your overall grade): The primary work for this course will consist of 12 problem sets. (There will be no formal midterm or final exam.) These problems sets will typically be handed out on a Thursday, due the following Thursday in class. (You will always be given at least a week to work on these problem sets). They will include fairly straightforward problems that ask you to apply techniques and concepts that we have dealt with in class, to more challenging ones that ask you develop and support an analysis or argument. Your answers to these problems, and to the more challenging ones in particular, should be written in an essay-style structure and in logical, clear, and concise prose. These assignments should be typed and turned in at the beginning of the class on the day that they are due. Each assignment will be weighted equally in terms of how it will contribute to your final grade (each problem set = 6.67%).

You are encouraged and expected to work together on all assignments for this course. However, what you turn in must be your own work and written IN YOUR OWN WORDS. If you do work with others on assignments, always identify your collaborators on your write-up. Working collaboratively on assignments is practically a guarantee of greater success in this course (i.e. a better grade), and will also help establish a fun and collegial environment in the classroom.

Participation (20% of your overall grade): Participation is required in this class. This includes, but is not limited to, attending each class meeting, contributing to class discussions, and working on in-class activities.

Grading: Your grade on each component of the class will be determined on the basis of the percentage of points earned to points possible: 100-90% = A, 89-80% = B, 79-70% = C, 69-60% = D, 59-0% = F. Your final grade will be determined in the same fashion but taking into account the weightings described above (repeated here for the sake of clarity).

Problem Sets:	80%
Participation:	20%

Students are expected to keep track of their performance throughout the semester and to seek guidance from available sources (including the TAs and the instructor) if their performance drops below satisfactory levels.

Late Submission of Assignments: Turn in all assignments on time. Late assignments may be accepted (at the instructor's discretion) but with a grade penalty. These assignments are unlikely to be returned to you in a timely manner, and they will not receive the same amount of feedback as an assignment handed in on time.

Attendance Policy: At The University of Texas at Arlington, taking attendance is not required. Rather, each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. In this class, attendance is required. (See the *Participation* section above.) You are responsible for the material presented in class lectures and for any handouts passed out in class; so for your own benefit, come to class. Assignments are due on the day listed on the schedule, and no later, unless you make arrangements with the instructor prior to the due date.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing.
