Purpose and content of the course: This is the first part of graduate level Electromagnetism course. This course will introduce and discuss a formal mathematical and physical structure of Electromagnetism leading up to Maxwell's equations. It is expected that the students know the undergrad level electromagnetic theory and have some familiarity with the concept of vector calculus. The content of the course is about first six chapters of the main text book.

Home Work: Home work will be assigned periodically. Solutions will be available after the due dates. For each set HW, there will be class presentations by the students on home works. I am planning that each student would present at least 3 times during the semester. HW work grade will depend on the presentation. However, I need that you submit HW at the due date at the beginning of the class to receive the HW grade. Start working on the HW early. Due to the nature of busy semester, no late submission will be accepted. **Also, no make-up HW will be assigned.**

Exams: There will be three exams: All the exams will be of equal weight. Two of them will in-class exams, and one will be take home exam.

First exam date: 02/28/17.

Second exam date: 04/04/17

Final exam: 05/09/17.

There will be no make-up exam.

Attendance: Attendance in the class is highly encouraged. However, if you missed class/classes it is your responsibility to know what/when the HWs are given or if there is any change of plan.

First, second and third exam: 30% each.
