Description of Course Content: Laboratory experience involves design and development work of systems with practical applications. A few examples include temperature and pressure monitoring systems, radar systems for collision avoidance, and soil moisture detection systems. Students work in teams and go through standard design and development steps that may be encountered in industry.

Required Textbooks and Other Course Materials: No required textbook for the laboratory section.

Descriptions of major assignments and examinations: Students will be expected to submit 2 intermediate reports on progress on the project as well as a final report. A final demonstration of performance of the system will be expected at the time of the final report submission. Quizzes may be given if deemed necessary by the instructors to ensure students remain on track during the course.

Attendance: Attendance is strongly encouraged.

Grading: Approximately 50% of the grade will be based on progress reported in the 2 intermediate reports on progress (and any quizzes that may be given). The remaining 50% of the grade will be determined based on the final report, demonstration, and peer evaluation.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. Student Feedback Survey: At the end of each term, students enrolled in face-to-face and online classes categorized as “lecture,” “seminar,” or “laboratory” are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student’s feedback via the SFS database is aggregated with that of other students enrolled in the course. Students’ anonymity will be protected to the extent that the law allows. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
