**Description of Course Content:** A combination of field-related experience in the business or service sector with an academic component. - Student must be enrolled at UTA BA in Translation and Interpreting and seeking course credit for internship hours and permission of the instructor.
- Student must be enrolled in SPAN4341, SPAN4342, SPAN4343, SPAN4344 or must have finished his training in translation and/or interpreting.
- Good command of both English and Spanish
- A dedicated commitment to the duration of the projects as stipulated by the internship agreement.

**Duties/Learning goals:**

- Support of Project Management staff – all steps of the translation process
- Analyze original documents and determine translation objectives
- Extract terms and compile term bases
- Compile instructions for translators according to client specifications
- Resolve translator inquiries
- Process various file formats for translation, including basic layout/formatting

- Prepare translation files for use in a CAT tool (SDL Trados or MemSource)
- Translate short documents from various verticals (life sciences, legal, manufacturing, education/e-learning) using CAT tools
- Review translated documents (proofreading & editing)
- Quality Assurance/side-by-side check of translated documents
- Review techniques of consecutive and simultaneous interpreting and sight translation
- Review over-the-phone interpreting techniques
- Practice note-taking for interpreters (Rozan's method)
- Review basic ethical concepts of the profession
- Shadow a TLC staff interpreter on assignment (if available and with client's consent)
- Interpret at community interpreting assignments (if available)

**Descriptions of major assignments and examinations:** professional collaboration with Teneo Linguistics Company and one-to-one session with the instructor to discuss the significance of the experience (strong and weak points).

**Attendance:** At The University of Texas at Arlington, attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this course, I have established the following attendance policy. Attendance is mandatory. After two absences the student's grade will be lowered 2% for each absence. Participation is mandatory; if the student doesn't participate on a daily basis his/her grade will be affected significantly. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Other Requirements:** Common Courtesy. Please do not enter class late. Every third tardy (10 minutes late) will count as one absence. Please, turn off your cell phone before entering class.

10% one-to-one session with the instructor to discuss the significance of the experience (strong and weak points).

**Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as “lecture,” “seminar,” or “laboratory” are directed to complete an online Student Feedback Survey (SFS). **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
