<u>**Time and Place of Class Meetings:**</u> Class will meet weekly online in Blackboard. While most class participation is asynchronous, some synchronous online activities may be required.

Description of Course Content:

Clinical management of the high-risk neonate using evidence based-knowledge, research, and pharmacologic and technologic therapies. Focus on the following systems: pulmonary, cardiovascular, gastrointestinal, hepatic, renal, hematologic, and metabolic/endocrine.

<u>Other Requirements</u>: Prerequisite: NURS 5204, 5316, 5334. Pre-requisite or concurrent enrollment with 5367. As this course is offered in an online format, **each student must have a computer with a <u>high speed internet connection</u>. This course requires the use of word processing software that is compatible with Microsoft Office formats. Testing will be done online using Respondus browser and monitor (which students must download from a link within Blackboard and install on their computer). The instructor will determine what option is offered to students who are unsuccessful in completing a test online. Students may be required to complete an alternate version of the test using ProctorU for which students must pay a fee.

- 1. Assess, diagnose, and plan for the management of health care needs of the high-risk neonate using evidence-based knowledge.
- 2. Use pharmacologic and technologic therapies in the management of the high risk neonate's complex acute and critical illnesses.
- 3. Develop plans for health promotion and disease prevention in the care of the high-risk neonate within their family system.

Expectations of Out-of-Class Study: Beyond the time required to participate in class each week, students enrolled in this course should expect to spend at least an additional 15 hours per week on their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

If the author's ideas are rephrased, by transposing words or expressing the same idea using different words, the idea must be attributed to the author by proper referencing giving the author's name and date of publication. If a single author's ideas are discussed in more than one paragraph, the author must be referenced, according to APA format. Authors whose words or ideas have been used in the preparation of a paper must be listed in the references cited at the end of the paper.
