**Time and Place of Class Meetings:** Tu/Th 10:30 a.m.- 12:20 p.m. at WH 308

**Description of Course Content:** Crystal structure and defects in materials. Diffusion, phase diagrams and phase transformations in metallic systems. The inter relationships between processing, structure, and properties of engineering materials with emphasis on the mechanical behavior of metals, polymers, and composite materials.

**Student Learning Outcomes:** Development of an understanding of the basics of atomic/micro structure – mechanical property relationship that interfaces between the disciplines of the mechanical/ aerospace engineering and the materials science and engineering, including an understanding of defect/failure mechanisms in engineering materials, strengthening/toughening mechanisms, and phase diagrams.

**Required Textbooks and Other Course Materials:**

Fundamentals of Materials Science and Engineering: An Integrated Approach, 4th ed., by William Callister, and David Rethwisch.

**Descriptions of major assignments and examinations:** There will be two mid-term exams (to be scheduled depending on course progress) and a final exam.

**Attendance:** Students are required to attend each class. Attendance checks are treated as quizzes (two checks = 1 quiz). If no quiz is given, quiz grading points are solely determined by attendance.

- If missing more than **one quarter of classes**, a student would automatically receive “**C**” grade or lower.
- If missing more than **one half of classes**, a student would automatically receive “**F**” grade.

**Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
