**Description of Course Content:** This course discuses conceptualization, analysis, and design of power electronics components, circuits, and systems. It discusses different classes of switching converters (dc-dc, ac-dc, dc-ac) and elements of power electronics (magnetic design, loads, and capacitors). Applications of power electronics in renewable energy systems and vehicular electronics are discussed.

Student Learning Outcomes: Upon successful completion of this course, students will have the ability to

- Understand the basic principles of energy conversion using switching circuits
- Size power electronics components, from passive elements (e.g., magnetics) to switching components
- Analyze the operation of AC-DC, DC-DC, and DC-AC converters

Required Textbooks and Other Course Materials: The instructor will use following references:

- "Power Electronics" by D. W. Hart, New York: McGraw Hill.
- "Elements of Power Electronics" by Philip Krein, The Oxford Series in Electrical and Computer Engineering.
- "Fundamentals of Power Electronics" by Robert W. Erickson and Dragan Maksimovic, Springer.

**Descriptions of major assignments and examinations:** There will be one midterm exam and one final exam. Homework questions will be assigned, but will not be collected/graded. Instead, in-class quiz will be given from the same set of homework problems.

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I have established a mandatory attendance policy. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade

of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Other Requirements:** Students are expected to be familiar with Circuit Theory and Electronics. Otherwise, consent of the instructor is required.

**Grading**: Quiz constitutes 20%, midterm is 40%, and the final exam is 40%. The letter grade distribution is shown below.

Students enrolled in this course should expect to spend at least an additional 9 hours per week of their own time in course-related activities, including reading materials and simulation projects.
