### **COURSE DESCRIPTION**

Historical geography can be defined as “the study of the geography of the past”. In this course, we will examine the geography of the United States from the colonial era to the mid-nineteenth century. The study of historical geography involves viewing geography through the lens of time by asking how geographic patterns have changed over time. It also involves viewing history through the lens of geography by asking how geographic patterns have influenced the events of the past.

6. Analyze and evaluate graphics such as maps, figures, tables, and photographs related to U.S. historical geography.

You will not be successful in this course if you don’t attend class meetings.**

### **GRADING POLICY**

Your final course grade will be calculated as follows: Essay Exams (5 @ 10% each), Discussion Outlines (25%), and Attendance & Participation (25%). See Blackboard for all assignment instructions and grading rubrics. The grading scale for the course is: A = 90-100%; B= 80-89%; C= 70-79%; D= 60-69%; F = below 60%. Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels. ### **EXPECTATIONS FOR OUT-OF-CLASS STUDY**

Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional **9-12** hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.
