Course Learning Objectives: Upon completion, students will be able to identify the main components of modern WDM systems, make simple estimates of system’s performance under various conditions, and design a system with appropriate parameters for given application.

Course Description: Course reviews the modern WDM systems and methods of their design. Topics include: architecture of state-of-the-art WDM systems; design of optical amplifiers; signal-to-noise-ratio budget; estimation of various system impairments; popular modulation formats; transmitter and receiver design issues; balancing optical nonlinearity and dispersion; optical networking; and characterization of WDM system’s performance.

Pre-requisite: There is no formal pre-requisite, but some familiarity with optics is recommended (e.g., by taking previously or concurrently one or more of EE5380, 5384, 5385 courses).

Tentative topic schedule:

- Review of modern commercial WDM systems architecture
- Amplified spontaneous emission noise
- System’s signal-to-noise-ratio budget
- Rules-of-thumb in estimation of system impairments
- Transmitter and receiver design issues
- Commonly used modulation formats
- Erbium-doped fiber amplifiers and their design
- Lumped and distributed Raman amplifiers
- Nonlinear-optical impairments
- Choice of dispersion map
- Optical networking with add-drop multiplexers and cross-connects
- System characterization techniques (Q-factor estimation, recirculating-loop operation, etc.)

Course format: the course will consist of lectures (slides) (50%) and student’s presentations/discussions reviewing recent progress in this field (50%).

Course Evaluation and Final Grade:

Attendance and class participation	50%

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. **As the instructor of this section, I expect every student to attend the class, and I may take attendance sporadically.** However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Student Feedback Survey: At the end of each term, students enrolled in face-to-face and online classes categorized as “lecture,” “seminar,” or “laboratory” are directed to complete an online Student Feedback Survey (SFS). Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
