**Time and Place of Class Meetings:** Tuesday and Thursday 5:00 pm–6:20 pm, SH 129

**Description of Course Content:** Physical, mechanical, electrical, optical, magnetic, thermal and chemical properties of metals, semiconductors, ceramics, polymers, composites, and aggregates and the relationships between these properties and the electronic, crystal, micro and macro-structures of the materials. Prerequisites: CHEM 1442 or CHEM 1465; PHYS 1444.

**Student Learning Outcomes:** After completing this course, students will be able to (1) describe the micro and macroscale structures of engineering materials, their physical and chemical properties, and the relationships between their structures and properties and (2) apply the knowledge to design, process, and/or use the materials for engineering applications.

**Required Textbooks and Other Course Materials:** “Materials Science and Engineering: An Introduction” by William D. Callister, Jr and David G. Rethwisch, 9th Edition

**Descriptions of major assignments and examinations:** Homework assignments, two 80 minute in-class exams, and final exam. No late homework will be accepted unless prior arrangements are made with the instructor for valid excuses. There will be no makeup exams: If you have a valid reason for missing an exam, I will work with you to reach an acceptable time to take the exam. Cases will be dealt with on a case-by-case process.

**Attendance:** At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I will factor attendance into the grade (15%) as follows: A (full credit) 0-1, B 2-3, C 4-5, D 6-7, F (no credit) > 7 unexcused absences. If you have an excuse, you must notify me via email (preferably in advance). However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients “begin attendance in a course.” UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Grading:** The final grade will be calculated based on Homework (15%), Exam 1 (20%), Exam 2 (20%), Final Exam (30%), and Attendance (15%). Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels; see “Student Support Services,” below.

**Make-up Exams:** Make-up exams will not be provided unless special circumstances warrant.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. **Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
