Description of Course Content: The nature and properties of materials used in civil engineering such as structural metals, concrete, timber, and bituminous materials. The engineering properties and behavior of materials are emphasized.

Specific Outcomes of Instruction: Students will demonstrate an understanding of engineering properties of materials generally used in the CE/Constructional applications. Due to the time restraint, only the following materials will be discussed in this semester: Wood, Aggregates, Cement Concrete, Asphalt Concrete and Steel.

Description of major assignments and examinations:

- Several Homework Assignments: Homework is due at the beginning of the class in the day instructed. Late homework will not be accepted, and will not be graded.
- Two mid-term exams will be administered.
- One comprehensive final exam will be administered. All exams are closed book and closed notes, unless otherwise directed by instructor.

Attendance Policy: At the University of Texas at Arlington, taking attendance is not required. Rather, each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I expect all students to attend all classes and to be punctual. Make-up Exam Policy: No make-up exams are given except for medical or other similar hardships where advanced arrangements are made with the instructor; or in case of non-selective medical emergencies with **appropriate** physician's note or documentation. Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional $\underline{6(\text{six})}$ hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period.
