Description of major assignments and examinations:

- Several Homework Assignments: Homework is due at the beginning of the class in the day instructed. Late homework will not be accepted, and will not be graded.
- Two mid-term exams will be administered.
- One comprehensive final exam will be administered. All exams are closed book and closed notes, unless otherwise directed by instructor.

Attendance Policy: At the University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I expect all students to attend all classes and to be punctual. Make-up Exams: No make-up exams are given except for medical or other similar hardships where advanced arrangements are made with the instructor; or in case of non-selective medical emergencies with **appropriate** physician's note or documentation. Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional $\underline{6(\text{six})}$ hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.
