### Course Description:

ENGL 3333 Dynamic Traditions in Literature is a new course, described in the course catalog as “an introduction to literary study that focuses primarily on changes over time to a movement, genre, or motif.” This section will focus on changing ideas and representations of work in American literature and culture from the mid-nineteenth century to the late twentieth century. We will begin with Frederick Douglass’s account of his forced labor as a slave before the Civil War; his experience of work plays a critical role in his movement towards freedom. The other texts we read and films we watch portray a wide range of different kinds of work, performed by domestic workers, waitresses, factory workers, telegraphists, and modern office workers, among others. The topic of work inevitably raises questions of hierarchy, inequality, exploitation, and social justice. We will explore the social meanings of work in these texts, including their engagement with class, race, and gender. We will examine the distinctive customs and relationships that form in the workplace, the conflicts and dysfunction, as well as the satisfactions of work, its expected, surprising, or illicit pleasures.

Note: Films will not be shown in class, so you will need to purchase or rent them. They must be viewed before the class in which they are discussed. **Course Requirements:**

1. Two papers (4-6 and 8-12 pages). Papers must be submitted through Blackboard.
2. Midterm.
3. Final exam.
4. Reading quizzes. Because these quizzes are part of the daily work of the course, a measure of your preparation and participation, make-ups will not be offered if you miss class on the day a quiz is given.
5. Participation in class discussion.

**Note:** All major assignments (i.e., both papers, midterm, and final) must be completed in order to pass the course.

**Attendance, Participation, Preparation:**

Student participation is an extremely important part of this course. The course will primarily be organized around discussion of the readings, rather than lectures; student interests will play a major role in shaping our discussions. I expect you to come to class having carefully read the texts for each day's meeting, prepared with questions, ideas, enthusiasms, or objections. Because this course depends on your full involvement, regular attendance is also essential for its success.

At The University of Texas at Arlington, taking attendance is not required. Rather, each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

As the instructor of this section, I have established the following policy: More than three absences will have a significant impact on your grade for the course. More than eight absences may result in failure for the course. Arriving late to class or leaving early is disruptive; a pattern of late arrivals or early departures will also affect your grade.

**Policy on Electronic Devices:**

Please turn off and put away all cell phones, laptops, tablets, and other electronic devices at the start of each class. Such digital devices are of course essential academic tools, but their potential to be distracting can outweigh their value in the classroom. I will make exceptions to this policy for particular class meetings in which we are discussing e-texts.

**UTA Drop Policy:**

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. Students will not be automatically dropped for non-attendance. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. **Student Learning Outcomes:**

Students should be able to:

- Demonstrate critical understanding of the specific authors and texts covered in the course, and identify connections synthetically between these texts.
- Demonstrate knowledge of major themes and issues relevant to course literature, particularly the topic of work and the workplace.
- Demonstrate a complex understanding of the relationship between literary texts and significant historical and cultural contexts, including analyzing the relevance of important historical events or topics to specific texts.
- Explain and make use of analytical and theoretical concepts and literary critical terminology covered in the course.
- Express ideas and perform analysis in clear, concise, logical, and persuasive writing.
- Express ideas clearly through relevant oral contributions to class discussion, and respond substantially and respectfully to the ideas of other students.

**Academic Integrity:**

Students enrolled in all UT Arlington courses are expected to adhere to the UT Arlington Honor Code:

### **Final Review Week:**

A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
