#### **Description of Course Content:**

Historical geography can be defined as "the study of the geography of the past". The study of historical geography involves viewing geography through the lens of time by asking how geographic patterns have changed over time. It also involves viewing history through the lens of geography by asking how geographic patterns have influenced the events of the past.

Student Learning Outcomes: Upon completion of this course, students will be able to:

- 1. Understand and analyze historical geography concepts.
- 2. Apply the concepts of historical geography to the history and geography of the United States.
- 3. Interpret and evaluate written works in the field of historical geography.
- 4. Construct and defend historical and geographical arguments.
- 5. Articulate in writing and verbally the ideas, concepts, and arguments of the field of historical geography.
- 6. Analyze and evaluate graphics such as maps, figures, tables, and photographs related to U.S. historical geography.

### Descriptions of major assignments:

- 1. Quizzes and In-Class Writing: Unannounced quizzes and written assignments will be given during class.
- Story Map Project: Create a "Story Map" on a topic of interest to you that relates to the historical geography of the U.S. since 1850. Project possibilities and expectations will be discussed in more depth in class. Each student will present his/her story map at the end of the semester. - 3. Participation in Seminar Discussions: A seminar-oriented class is most effective and educational when all members of the class attend class meetings and come to class prepared to discuss the reading assignments. I will monitor your participation in discussions and note the degree to which you appear prepared to discuss the assigned readings. You will receive a grade three times during the semester. Please make me aware of any mitigating factors that I should take into consideration when calculating your grade.

**Grading**: Each major assignment will count 1/3 of your final course grade. The grading scale is: A = 90-100%, B = 80-89%, C = 70-79%, D = 60-69%, and F = below 60%.

**Attendance:** At the University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I will take attendance each week and will monitor your participation in seminar discussions. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. **Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. UT Arlington's effort to solicit, gather, tabulate, and publish student feedback is required by state law and aggregate results are posted online. **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

**Emergency Exit Procedures:** Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit. When exiting the building during an emergency, one should never take an elevator but should use the stairwells.
