Description of Course Content: Introduction to William Caplin's Formal-Function Theory, including mastery of formal functions, harmonic progressions, the principal theme types, and full-movement forms. Seminar designed to meet the needs of students desiring to become theorists or teachers of theory.

Student Learning Outcomes: Exploration and mastery of formal functions, harmonic progressions, the principal theme types, and full-movement forms.

Required Textbooks and Other Course Materials:

William Caplin, *Analyzing Classical Form: A Classroom Approach*, OUP, 2013 Other materials to be distributed to students through blackboard or copies.

Descriptions of major assignments and examinations: Analytical assignments will be assigned throughout the semester and discussed with the instructor and other students at the class meetings. The final project will be a focused, detailed analysis of a given piece and/or technique using Caplin's analytical method. There will be no final examination.

Attendance: At The University of Texas at Arlington, taking attendance is not required. Grading: Grading will be calculated based on performance on analytical assignments as the final Capstone Presentation

Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
