## **Textbook:**

An Introduction to Cardiovascular Physiology, 5<sup>th</sup> Edition, (J.R. Levick.) will be used as the primary reference text with selected readings to be assigned as needed.

## **Course description:**

This course will address the structure and function of the cardiovascular system, as well as cardiac control, the cardiac cycle, cardiac output, hemodynamics, vascular resistance, oxygen delivery and consumption, heat production and thermal control during exercise. Topics will be addressed in lecture.

## **Student Learning Outcomes:**

Students will gain a comprehensive understanding of the structure and function of the cardiovascular system with emphasis on cardiac and vascular function and control. Content will be delivered in the lecture.
