Learning Objective:	 This course will enable students: to develop skills to idealize, formulate, and analyze determinate and indeterminate structures (beams, trusses, and frames) using structural analysis methods. to present methods to determine structural forms, and basic shear and moment diagrams, deflected shape to develop skills in interpreting and predicting solutions from structural analysis. to introduce computer-based applications for the analytical methods as presented.

Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
