Course Objectives:

This course will provide students with an opportunity to systematically study systems analysis and design. Both technical and practical knowledge will be emphasized. A variety of topics will be covered to familiarize the students with the concepts and techniques underlying analysis and design. Specifically, three primary areas will be covered:

- (1) Project Initiation and Requirements Determination;
- (2) Analysis Modeling; and
- (3) Design Modeling.

Letter Grade Scale:

We will not be using a fixed scale for determining the letter grade. The cutoff points for different letter grades will be based on the class average and class standard deviation of the final score. Cutoff points will be strictly enforced without any rounding.

Cutoff for A: (Class average) + 0.5(Class standard deviation)

Cutoff for B: minimum of $\{80, \text{Cutoff for } A - 10\}$ Cutoff for C: minimum of $\{70, \text{Cutoff for } B - 10\}$

So, to get an A your final score should be at least half a standard deviation above the class average.

Attendance:

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period.
