Description of Course Content: Computer organization from the viewpoint of software, including: the memory hierarchy, instruction set architectures, memory addressing, input-output, integer and floating-point representation and arithmetic. The relationship of higher-level programming languages to the operating system and to instruction set architecture are explored. Some programming in an assembly language. Prerequisite: CSE 1320..

Student Learning Outcomes: Upon successful completion of this course, students will understand the design concepts used to establish the interface between hardware and software in modern computer systems. Students will also be able to solve problems with assembly language programming while understanding the advantages and disadvantages of various approaches.

Descriptions of major assignments and examinations: The final letter grade for this course will be based on scores received on regular homework and programming assignments, online quizzes, a midterm exam, and a final exam. Homework and programming assignments are to be submitted electronically via Blackboard. Late assignments will be accepted with a 20% penalty applied for each day late up to 2 days. Assignments submitted later than 2 days after the original deadline will not be accepted.

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. 2-Week Grade Grievance Policy: Once a grade has been posted, you will have 2 weeks to contest your grade with whoever graded that assignment. The GTA will grade the Homework, and the Instructor will grade quizzes and exams. Once a grade has been posted for 2 weeks, the grade is final and will not be changed.

Make-up Exams: Make-up exams will only be allowed under extraordinary circumstances and must be approved by the instructor, whose decision is final. If an exam is missed due to unavoidable circumstances, the instructor must be notified of the situation as soon as possible. Travel will not be considered as a valid excuse for missing an exam, unless for the purpose of representing the university or department. Any exams that are missed due to unexcused reasons will receive an automatic grade of zero.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing.
