1. Course Content

Trombone Pedagogy is an exploration of the “what, why and how” to impart instruction in applied study. The focus here is on fostering an awareness of how to best teach private students in a one-on-one lesson format in the basics of brass performance skills, with the goal of helping those students become more proficient instrumentalists and better musicians.

2. Student Learning Outcome

The intent of this course is to provide the pedagogy student with a broad overview of the most predominant themes in contemporary trombone teaching, and an understanding of what methods, techniques, and approaches to employ to become an effective teacher.

3. Attendance Policy

Trombone Pedagogy will meet once or twice a week as needs indicate, based on assigned readings, as well as occasional individual sessions to consult on student projects.

At the University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

4. Required Material

The basic required texts for this class are Philip Farkas: The Art of Brass Playing, and Daniel Kohut: Musical Performance...Learning Theory and Pedagogy. Additional reading material from other sources will be periodically assigned by the instructor and provided by him.

5. Individual Projects

Each student is responsible for developing, researching and producing an in-depth semester project, the topic and format of which is to be approved by the instructor in consultation with each student. While the nature of this project is almost unlimited in scope, it is hoped that the student will select a topic that will be of value to the student's individual interests in regard to both his/her continued academic work as well as their long-term interest.

6. Grades

Grades will be determined by satisfactory completion of the required readings and participation in group discussions (50%), as well as evaluation of individual projects. Completed projects are due no later than the final day of classes.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. Students will not be automatically dropped for non-attendance. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
