**Description of Course Content:** The objective of this course is to introduce you to the life of the prokaryote. From the perspective of both age and biology, this fabulously diverse group of organisms is unlike any other form of life on the planet. While widely known for their medical importance, these organisms also play important roles in maintaining our environment, supplying food and medicines, and as vehicles by which we may understand the expression of genetic information. The material that we will cover is broad and voluminous; fortunately, it is also interesting. Upon completion of the course of study you should understand the major differences between the types of cellular life on the planet, you should understand how prokaryote metabolism differs from the metabolism of cells with a nucleus, you should understand how antibiotics function, and you should be able to understand some fundamental aspects of how your body responds to infections.

#### **Student Learning Outcomes:**

The intended **learning outcomes** are as follows. By the end of the course students should have knowledge of;

- How microorganisms are used as model systems to study basic biology, genetics, metabolism and ecology.
- 2. The ways microorganisms play an *integral role* in disease, and microbial and immunological methodologies are used in disease treatment and prevention.
- 3. Why microorganisms are *ubiquitous in nature*; inhabiting a multitude of habitats and occupying a wide range of ecological habitats.
- 4. Examples of the *vital role* of microorganisms in biotechnology, fermentation, medicine, and other industries important to human well-being.
- 5. How microorganisms have an *indispensable role* in the environment, including elemental cycles, biodegradation, etc.



**Descriptions of major assignments and examinations:** Your grade in this course will be based on your scores on four midterm exams, the optional final exam and your answers to questions asked during class. **In addition, the laboratory portion of this course will constitute 20% of your final grade.** The optional final exam gives a student an opportunity to "redeem" a poor exam 1, 2, 3 or 4 performance, or "replace" an unexcused missed exam. Please remember the final exam is COMPREHENSIVE and requires significantly more effort than the four (4) regular exams! Students are encouraged to study and complete the four exams during the regular course period and not depend on the final exam. The third option is that the final exam and your laboratory grade can together be used to determine your overall grade in the course. More details are provided below.

Make-up Exams: Make-up exams will be allowed only in extreme circumstances at the discretion of the Instructor. You should have a doctor's note in case of illness. Notify me (by email, phone, note etc. AS SOON AS you are aware of a problem, prior to the exam. Missed exams will receive a score/grade of zero "0". Makeup exams will consist of 5 short answer essay questions.

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, *I strongly encourage students to attend all lectures. I allow students to attend class at their own discretion.*However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Lab safety training: You must complete all required lab safety training prior to entering the lab and beginning work. Once completed, Lab Safety Training is valid for the remainder of the same academic year (i.e., through the following August) and must be completed anew in subsequent years.
