Course Description

Special studies in broadcasting: Videography of the 4th Colombian Navy Expedition to Antarctica.
Prerequisite: BCMN 3340, BCMN 4191, fully bilingual in English and Spanish, experience in producing Spanish-language broadcast journalism, ability to travel internationally (U.S. Passport), clear all medical protocols associated with traveling internationally, 60 or more hours earned, permission of the department, and permission of the instructor.

Learning Outcomes

1. Student will gain knowledge on the fundamentals of videography at sub-zero temperatures.
2. Student will gain knowledge of scientific research carried out at multinational bases in Antarctica.
3. Student will produce audiovisual content documenting the 4th Colombian Navy Expedition to Antarctica.
4. Student will apply field electronic news gathering and audiovisual content management principles.
5. Student will demonstrate she/he can think critically, creatively, and independently.

Textbook, Tools, and Other Requirements

1. Readings may be assigned at the discretion of the instructor.
2. Solid State External Hard Drive with USB 3.0 connectivity (1TB capacity minimum).
3. Secure Digital Extended Capacity (SDXC) Card, Class 10 (64 GB Minimum).
4. Student will be required to travel internationally for an approximate period of 10 days.

Class Grading and Rules

Assignments: Student will travel to Antarctica with faculty from the Department of Communication at the University of Texas at Arlington and the School of Law at the Universidad Católica de Colombia, Colombian politicians, and military personnel from the Colombian Navy and Air Force part of the scientific expedition. Traveling to Antarctica and doing field work will represent 50% of the final grade. Editing and producing a short audiovisual documentary will represent the remaining 50% of the grade.

Attendance/Drop Policy: Student must meet and work with the instructor during the scheduled time and during the international trip. It is the student's responsibility to drop or add the class—not the faculty or staff's. See more on UTA's drop policy below.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. Students will not be automatically dropped for non-attendance. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Student Feedback Survey: At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes

are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures: Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit. When exiting the building during an emergency, one should never take an elevator but should use the stairwells.
