Students are encouraged to meet with the professor regarding concerns about the course during office hours or at an agreeable time.

## **Course Description:**

Graduating seniors will present a visual/oral representation of their journey as an artist and an educator.

## **Course Prerequisites:**

All required coursework necessary for graduation including residency.

## **Course Objectives:**

- 1. Students will deliver an oral/visual presentation at the end of their last semester before graduation (i.e. PowerPoint, Prezi, Tabblo, etc.).
- 2. Students will present a visual representation of their portfolio and discuss their journey as an artist.
- 3. Students will present information about their residency/student teaching experience and display artwork from the students they taught as well as narratives, stories, testimonials, and more from interaction between student and educator.
- 4. Students will tie experiences together and show how they became intertwined.

## **Course Expectations:**

Students will meet individually with the professor to discuss their senior presentation. All aspects of the presentation will be covered.

Oral/visual presentation will be 25-30 minutes and students are required to arrive a half-hour before presentations are given. Presentation will be a combination of their own artwork as a student as well as the student's experience as an educator in the K-12 classroom during residency. Both the personal artwork and the K-12 students' artwork must be presented in the form of a PowerPoint presentation or an alternative presentation program (if not PowerPoint, must be approved by professor).

# **Attendance Policy:**

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. # **Student Feedback Survey:**

At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. UT Arlington's effort to solicit, gather, tabulate, and publish student feedback is required by state law and aggregate results are posted online. ## **Final Review Week:**

For semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests

and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

# **Emergency Exit Procedures:**
