**Description of Course Content:** Introduction to the theory, methods and practice of interpreting. The student will become familiar with community interpreting (interpreting in school, medical and legal settings) and interpreting theory. The student will begin to interpret in the simultaneous and consecutive (bilateral) modes. The student will also learn about sight translation. Prerequisite: SPAN 3305 or SPAN 3314 with a grade of C or better. Non-native/heritage speakers are also encouraged to take SPAN 3303 prior to enrolling in SPAN 3341. SPAN 3341 cannot be applied toward the B.A. in Spanish.

**Student Learning Outcomes:**

- Learn the history of interpreting and how that history informs the current practice of interpreting today.
- Learn the basic interpreting theory and how that theory is applied to the delivery of competent, accurate interpreting.
- Perform competent, accurate interpreting in the consecutive and bilateral modes.
- Understand interpreting as a social and professional activity of intercultural communication.
- Identify interpreting in its social context.
- Know the professional interpreting market.
- Develop the ability to identify appropriate documentation resources and to be able to measure their reliability and to use them.
- Understand what elements are necessary to provide competent interpreting, and be able to critique interpreting by their peers.
- Develop self-concept as an interpreter and the security of your own work done.
- Understand the ethical consequences surrounding interpreting.
- Develop interpersonal competence and the ability to work in groups.

**Required Textbooks and Other Course Materials:**

There is not text book for this course, the reading material will be provided by the instructor of the course, as well as links to online references.

**Descriptions of major assignments and examinations:** Students are responsible for the reading to be discussed in class. Students will be asked to prepare written answers about the assigned reading and **turn them in via Blackboard.**

- The professor will collect and grade interpreting activities (audio files) and homework throughout the semester.
- No late homework will be accepted.
- Students should be prepared to interpret in class.
- Students will review the theoretical concepts debated in class and be able to discuss them.
- There will be several class discussions, a midterm (closing exercise in SP, which will be audio recorded).

**Attendance:** At The University of Texas at Arlington, attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this course, I have established the following attendance policy. Attendance is mandatory. **After two absences the student's grade will be lowered 2% for each absence.** Participation is mandatory; if the student doesn't participate on a daily basis his/her grade will be affected significantly. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Grading:**

**Make-up Exam Policy:** There are no make-up exams except in cases of demonstrable emergencies.

**Expectations for Out-of-Class Study:** Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional **6-9 hours** per week of their own time in course-related activities, including reading required materials, research, completing assignments, preparing for exams, etc.

**Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
