COURSE DESCRIPTION:

This is an introductory linguistics course. It covers core areas in theoretical linguistics – phonetics and phonology, morphology, syntax, semantics and pragmatics. Additional areas may also be covered, such as sociolinguistics, language acquisition, and psycholinguistics.

STUDENT LEARNING OUTCOMES:

Upon successfully completing this course, students should be able to:

- identify and explain key terms and concepts in the fields of phonetics, phonology, morphology, syntax, semantics, pragmatics and other areas of linguistics;
- transcribe and read any language data that is written in IPA or a similar phonetic alphabet, as the first step toward analyzing the structure of the language;
- analyze the sound, word and sentence structure of natural language data using the methods of linguistic analysis taught in this course, whether or not the student has previous knowledge of the language;
- successfully solve language problems presented in class, so as to give students the confidence to further investigate theoretical issues and attempt more complex linguistic analysis in higher-level classes;
- identify and summarize a few major theoretical concepts that have influenced the field of language study

COURSE REQUIREMENTS:

<u>WEEKLY HOMEWORK ASSIGNMENTS</u> (30pts): There will be 10 homework assignments that are given on Thursdays and are due on the following Tuesday at the beginning of the class.

MID-TERM EXAM (30pts): This will take place in class on 10/14, and will cover topics from phonetics to syntax.

<u>FINAL EXAM</u> (30pts): Date will be announced. This will cover topics from semantics to animal communication.

<u>PARTICIPATION</u> (10pts): It is recommended that you come to class on time. However, note that you will be graded for your participation rather than mere attendance.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session.
