Time and Place of Class Meetings: Science Hall, rm 129, Tuesday/Thursday 9:30 am - 10:50 am

Description of Course Content: We will cover, some basic math and physics (matrix algebra, vector calculus, a review of Newton's Laws), Lagrangian and Hamiltonian dynamics, central forces (particularly gravity) and orbits, linear and nonlinear oscillators, and special relativity (time permitting).

Student Learning Outcomes: Your learning outcomes include an understanding of the theoretical basis of classical mechanics as evidenced by the ability to solve a variety of problems in the area listed above and the ability to describe what fundamental principles are involved in solving these problems.

Required Textbooks and Other Course Materials: Classical Dynamics of Particles and Systems, by Thornton and Marion, 5th Edition

Descriptions of major assignments and examinations:

Homework- Homework will be assigned regularly from the book. You will do better if you work in study groups. Some homework problems will be solved collaboratively in class.

- All homework MUST be submitted by email as a single PDF file for the entire assignment.
- You MUST use as the email subject: HW# (where # is the number of the homework).
- The Filename MUST be in the form: hw#lastname.firstname.pdf

Homework not submitted with this format will not be graded and instead get a zero. Please note that the format is case-sensitive.

Notecards- At the end of each class you are to fill out an index card with a question you have about the class content and turn it in.

Class Structure - This class will be taught as partially "flipped" class. Selected lectures will be on line and class will consist of a mix of lecture and collaborative solving of homework problems. Online lecture will also include "concept questions." When you get to one of these, I will give you a chance to stop the lecture and write your answer in your notebook. I will examine

notebooks in class. Concept questions will also be used during the lecture portions of class. Discussing concept questions and participating in problem-solving constitutes class participation.

Exams – There will be 3 midterm exams and a comprehensive final.

Attendance: Attendance is not required, but if you are going to miss a class, let me know since class participation is part of the grade. Failure to attend class is generally correlated with failing the course as a whole. If for some reason, you will miss an exam, you must let me know as soon as possible and make arrangements to take a make-up exam before the following class when the exam solution is discussed. Failure to do so will result in a zero on the exam.

3 midterm Exams - 45% (the lowest exam grade will be dropped) Homework- 20% Notecards and class participation - 5% Final Exam - 30%

Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional 8 hours per week of their own time in course-related activities, including reading the textbook, completing assignments, preparing for exams, etc. This class will be taught as a "flipped" class.
