**Description of Course Content:** This course provides an introduction to the workings of state and local government in the state of Texas and places Texas within a comparative framework.

**Political Science 2312 learning objectives/outcomes:**

Upon completion of this course, students are expected to be able to:

- 1). Define fundamental concepts associated with state politics through appropriate responses on exams.
- 2). Explain the theoretical and historical underpinnings of state constitutions; achieve basic understanding of the Texas constitution's content.
- 3). Describe the structure, function, powers of the differing branches of state governments and their influence on public policy.
- 4). Describe the evolving history of elections, eligibility, and impact of participation on democracy.

**Required Textbooks and Other Course Materials:** Halter, *Government and Politics of Texas*, 7<sup>th</sup> ed. ; Harrigan and Nice, *Politics and Policy in States and Communities*, 10<sup>th</sup> ed.

**Descriptions of major assignments and examinations with due dates:** Your grade for this course will be determined based on your performance on three multiple-choice exams. Each exam will be worth 1/3 of your grade. The final exam will be cumulative.
